Introduction and overview

Teacher's QTS (qualified teacher status) are subject to statutory regulation. The secretary of state for education is the regulator and the regulatory activity is carried out on their behalf by the Department for Education (DfE) and the teacher regulation agency (TRA). For the purpose of this apprenticeship, this will be referred to as the 'regulator' throughout. The regulator sets the standards of competence required for registration as a qualified teacher QTS on the professional register.

The regulator has the statutory duty to set requirements of programmes necessary to support the achievement of the knowledge, skills, and behaviours (KSBs) in the occupational standard. The apprenticeship standard and the delivery of the apprentices training must be aligned to all relevant regulator standards to ensure that apprentices are eligible for registration with QTS on completion. QTS is a legal requirement to teach in maintained schools and is considered desirable for teachers in the majority of schools in England.

This document sets out the requirements for EPA for the teacher QTS statutory integrated apprenticeship standard. It is for the end-point assessment organisations (EPAO), that must be accredited by the regulator, or in an accredited partnership to deliver initial teacher training (ITT) and make recommendations for QTS. It will also be of interest to apprentices and their employers.

Full time apprentices will typically spend at least 45 months on-programme (before the gateway) working towards the occupational standard.

Apprentices who start training having already met the legal requirement for entry to post graduate ITT to hold a first degree, must complete at least 12-months training on programme (before gateway) working towards the occupational standard.

The EPA period should only start, and the EPA be arranged, once the employer and training provider are satisfied that the apprentice is consistently working at or above the level set out in the occupational standard and all the pre-requisite gateway requirements for EPA have been met.

The EPA period is expected to last a maximum of 1 month beginning when the apprentice has passed the EPA gateway.

The EPA will determine the overall apprenticeship standard and grades of:

- fail
- pass

This apprenticeship has a statutory integrated EPA. The EPA will use the assessment arrangements in use for other entry routes into this occupation and will be completed simultaneously, as outlined in this end-point assessment plan. Alignment of the EPA is permitted because the following criteria are met:

1) the occupation (profession) must be regulated by a statutory regulator that carries out a range of functions in relation to the occupations they regulate, including making sure individuals have the necessary qualifications and/or experience to practise the occupation and taking any necessary enforcement action

and

2) the occupational standard and statutory integrated EPA meet the apprenticeship requirements

Gateway

The EPA period should only start once the employer and course provider are satisfied that the apprentice is consistently working at or above the level set out in the occupational standard.

The apprentice must have completed the following gateway requirements prior to beginning their EPA:

- achieved English and mathematics qualifications in line with the apprenticeship funding rules and the regulator's entry requirement
- BA or BSc in a degree that aligns with the occupational standard and leads to the award in QTS

or

 a post-graduate initial teacher training programme delivered by the regulator's accredited training provider

EPA

The statutory process aligned with the regulator's requirements and must have an external examiner present when considering achievement of qualified teacher status (QTS)

For those completing the 45 months on programme duration including achievement of the subject specialist degree:

The EPA starts with the examination board (HEP) of the degree and finishes when the accredited training provider, or in an accredited partnership sends the achievement details to the regulator to generate QTS status. The apprentice is not required to carry out any additional assessments.

or

For those completing 12 months on programme duration starting the apprenticeship with a recognised subject specialist degree:

The EPA starts with the accredited training provider, or in an accredited partnership external quality assurance moderation board of a post graduate ITT programme, and finishes when the moderation board sends the achievement details to the regulator to generate QTS status. The apprentice is not required to carry out any additional assessments.

The regulator will issue qualified teacher status, by recording the apprentice's achievement of qualified teacher status on the register, and issuing a letter to the apprentice confirming their teacher reference number.

Independence of the EPA will be assured through:

 the examination board or moderation board (which will include an external and appropriately qualified person or organisation, which is not an employee of the accredited training provider, and is not involved with the apprentice in their day-to-day work) being responsible for the final decision.

- have, maintain and be able to evidence, up-to-date knowledge and expertise of the occupation
- deliver the end-point assessment in-line with this EPA plan
- comply to the requirements of the EPAO
- comply with the IQA requirements of the EPAO
- have no direct connection or conflict of interest with the apprentice, their employer or training provider; in all instances; there must be no conflict of interest
- attend induction training
- make the grading decisions
- record and report assessment outcome decisions, for each apprentice, following instructions and using assessment recording documentation provided by the EPAO, in a timely manner

The regulator

As a minimum the regulator must:

- carry out a range of functions in relation to the occupations they regulate, including making sure individuals have the necessary qualifications and/or experience to practise the occupation and taking any necessary enforcement action
- issue a "license to practice" on successful completion of the "fit and proper person" application
- maintain a register of individuals admitted to the profession, and on which individuals need to be listed to be able to practice
- provide guidance of the level of competence apprentices need to attain to be added to the regulator's register
- inform IfATE of any upcoming changes to the regulator's requirements or assessment arrangements to enable a review of the statutory integrated apprenticeship

Internal Quality Assurance (IQA)

Internal quality assurance refers to the requirements that EPAO's must have in place to ensure consistent (reliable) and accurate (valid) assessment decisions. EPAO's for this EPA must:

- appoint external examiners or external moderators who:
 - hold any required qualifications and have recent relevant experience of the occupation at least the same level as a teacher QTS
 - meet the EQA provider's recommendations for external examiners or external moderators of the recommendation for the award of QTS

Re-sits and re-takes

In line with the EPAO's (regulator accredited training provider) procedures.

Statutory Regulator

This apprenticeship aligns with requirements for registration with the Department for Education for QTS.

Reasonable adjustments

The EPAO must have in place clear and fair arrangements for making reasonable adjustments for this apprenticeship standard. This should include how an apprentice qualifies for reasonable adjustments and what reasonable adjustments will be made. The adjustments must maintain the validity, reliability and integrity of the assessment decisions outlined in this EPA plan.
